Ontario Cultural Attractions Fund names John D McKellar and Nalini Stewart Chair and Vice-Chair of Board of Directors



He has, alone or with others produced shows at ArtWorld Theatre. Blythe Centre for the Arts. The St. Lawrence Centre for the Arts, The Princess of Wales Theatre, The Wintergarden Theater, The National Arts Centre, The Manitoba Theatre Centre and the Kennedy Centre in Washington and has several other theatrical projects now in development. ## **About OCAF**

The Ontario Cultural Attractions Fund (OCAF) was established in 1999. It has two aims: to increase cultural tourism by providing investments to assist Ontario organizations to develop, promote and present one-off or first time events, or a significant expansion of existing activity, which are designed to attract new tourists and visitors to cultural events; and to increase the earned revenue capability of the applicant organization.

Since 1999, the Government of Ontario has invested \$32 million in the Fund and the success of the over 450 initiatives in which OCAF has invested has led to a healthy replenishment of the Fund for future projects.

Attendance to OCAF funded events has reached 35 million to date.
